# 4.3. Barkway Park Golf Club

Redevelopment of Golf Practice Range and Golf Academy using imported inert material to raise the area by 2 metres in height.

Council had objected in strongest possible terms to the importation of material which could mean up to 200 lorry movements per day for a number of years. Herts County Council Development Committee is scheduled to discuss this on 20<sup>th</sup> January and eight of the affected parish councils including Hormead PC will make a combined representation objecting to the application. # 8. FOOTPATHS AND BRIDLEWAYS

#### 8.1. Parish Paths Partnership (P3)

The Parish Paths Partnership scheme consists of voluntary groups undertaking tasks which enable their local network of public Rights of Way to be used to their best advantage. As previously reported, Cllr Kilby and Marty Kilby had started discussions with the County Rights of Way people in 2007 and had walked all the parish paths reporting on possible improvements. Together with Cllr Benson they had attended a meeting with the Co-op Farms to extend rights of way over Co-op land in the parish. Cllr Benson submitted an explanatory paper on the P3 scheme which was discussed by Council.

**Resolved:** Council formally support the P3 group in the Parish which would receive the backing of the Parish Council (prop Cllr Benson; secd Cllr Denham) **Resolved:** A standing parish councilor be a member of the P3 group and that Cllr Benson be the first nominated member (prop Cllr Haselden; secd Cllr Pryor)
